## **AGM Minutes:**

### 1. Welcome and Recognition

Meeting was called to order at 6:30 pm.

The AGM was attended by most board members and several team coaches. There were two player family members, not being a board member or coach, in attendance. It was estimated that there were 20 in attendance.

The following people were recognized for services on the board, going beyond what is expected, or doing something new for SWM Kickers.

Kim Fordam for several years of service as Fundraiser Coordinator.

Pattie Warren for facilitating the SWM Kickers website upgraded to better technology and for Angie Winsman transferring/loading content.

Brian Samuel for taking the lead, Paul Carteaux for assisting, and Lakeshore HS boys team on Rockey Weed Field set up this past season.

Brittany Lovelace for assisting Angie Winsman, public relations & communications coordinator, by managing the SWM Kickers Facebook page.

Heidi Lockmann for assisting Christine Hein, treasurer, with providing the SWM Kickers Treasurer function.

Brian Lawrence, DOC, for establishing SWM Kickers Coach meeting. There have been 2 Coach Meetings so far with expectations of more to be scheduled later winter / spring.

#### 2. SWM Kickers 2018/2019 Review

Number of teams and players this seasonal year is similar to the previous seasonal year

President (Gil Urban), Director of Coaching (Brian Lawrence), Director of Player Development (Brian Samuel), Parent Representative (Jay Meeth), and At Larger Director (Casey Resseguie) positions were filled after last years Annual General Meeting

Current Board is operating well & working together in running SWM Kickers

SWM Kickers renegotiated and renewed the SJK outdoor and indoor facility agreement. The outdoor field fee was reduced 15% (~\$2,000).

Rockey Weed 2019 fall field setup was accomplished by SWM Kickers. Future field setup plans are to have it done through a Lakeshore HS booster club project lead by Brian Samuel & staffed by LS HS soccer players.

Uniform Committee formed chairman Julie Samuel; Capital Improvement committee formed, chairman Jay Meeth

Lakeshore Youth Soccer League is being integrated into SWM Kickers.

We are in the initial phase of working together in areas of common interest, such as signup/tryout flyer, Rockey Weed soccer complex, LYSL name changed to SWM LYSL, Spring 2020 new SWM Rec logo.

We have defined the organization structure to promote coordination and leverage but allow independent program operation. There will be a SWM Kickers soccer club Governance Board and each program SWM Kickers (competitive program) and SWM LYSL (recreation program) will have an Operating Committee. The current boards will transition into the respective Operating Committees.

Rockey Weed field lining by both SWM Kickers & SWM LYSL is working better this year. Most fields were lined each week.

Lincoln Charter Township has initiated 1<sup>st</sup> Rockey Weed complex improvement in several years. The Cleveland Avenue entrance with an additional gravel parking lot neared the U4/U6 fields.

Winter Player Technical Developmental training clinic has been setup, clinician coach Terry Sing. Other winter training items being consider.
